PART I. General Expectations

Palo Duro High School agrees to implement the following statutory requirements:

PART II. Description of how Palo Duro High School will implement the required components of the campus Title I Parent Engagement Plan.

1. Palo Duro High School will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan. Palo Duro Advisory Council meeting will consist of the following representatives: Parents, Community/business

members, teachers, students, and principal. The committee will evaluate the effectiveness of the plan each year. These meetings will be offered in English and Spanish.

- Palo Duro Advisory Council meeting will consist of the following representatives: Parents, Community/Business members, Teachers, Students and Principals. These participants will be invited by a phone call and a formal invite. The Committee will evaluate the effectiveness of the plan each year, all members present will be trained on what Title I entails and the importance of parent input. These meetings will be offered in English and Spanish.

2. Palo Duro High School will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - Parents and area community representatives are invited to attend all site-based decision making meetings. Interpreters will be available if needed
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - Staff support trainings will be held each year during professional development staff meetings.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Palo Duro High School will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Family Night/ Open House we have a Title I meeting, where we discuss what it means to be a Title I school.
- Title I information is also available at all parent meetings.

4. Palo Duro High School will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- The AISD and PDHS Course Guide lists what courses are offered and the counselor meets with each student to review their Individual Graduation Plan on a yearly basis. Progress reports and report cards are issued to the student to share with their parent.

5. Palo Duro High School will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Counselors hold periodic grade level and topic specific meetings for parents to attend. Parents can contact the school to set up a conference concerning their child and request a translator, if necessary.

6. Palo Duro High School will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Parents have access online through the Texas Education Agency to view. Our campus notifies parents through school messenger, flyers posted on our website, Remind 101, Twitter and Facebook.

7. Palo Duro High School will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following: Reviewing and understanding the state's academic content standards.

- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- Advanced Placement & Dual Credit Classes
- Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey.

8. Palo Duro High School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Discovery Center Science Family Night.
- Skyward Parent Training.
- ESL Parent Classes
- Parent Collaborators Leadership Academy
- Parent Education Classes
- Relationship Sessions: Session 1: Smart Dating, Session 2: Online threats, Session 3: Things that don't mix, Session 4: Supporting Teens with Anxiety & Depression.

9. Palo Duro High School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- A survey will be available to parents so they can provide input on what our school can do better to help them help their child.

10. Palo Duro High School will, to the extent feasible and appropriate, coordinate and integrate TI parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Freshmen kick-off orientation for parents and students to become familiar with our campus and meet the teachers.
- 8th Grade Orientation

11. Palo Duro High School will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- As needed, our campus provides an interpreter and translation services. The Language Line service may be used to communicate by phone with parents who do not speak English. Parent Involvement funds may be used to have materials translated, as deemed necessary.
